4. Usage Rights: The Client understands and agrees that the Photographer retains the copyright to all images taken during the session. The Client is granted non-exclusive rights to use the images for personal, non-commercial purposes, including printing, sharing on social media, and personal websites. The Client shall not sell or otherwise distribute the images for commercial purposes without the Photographer's written consent.

5. Model Release: The Client grants the Photographer the right to use the images for promotional purposes, including but not limited to, portfolio, website, social media, and marketing materials. If the Client does not wish to have their images used for such purposes, they must notify the Photographer in writing before or on the day of the photoshoot.

6. Rescheduling/Cancellation: In the event that the Client needs to reschedule or cancel the photoshoot, they must provide at least 3 days' notice. If the Client fails to provide sufficient notice, any deposit paid may be forfeited.

7. Delivery of Images: The Photographer agrees to deliver the edited images to the Client within 15 days after the photoshoot. The images will be delivered digitally via shared Dropbox folder.

8. Liability: The Photographer will take reasonable care in capturing and processing images. However, in the event of unforeseen circumstances, including equipment failure, the Photographer's liability is limited to a refund of any fees paid.

9. Unforeseen Circumstances: Neither party shall be held liable for any delay or failure to perform its obligations under this Agreement due to natural disaster, pandemic, government regulations, or any other cause beyond their control.

10. Entire Agreement: This Agreement contains the entire understanding between the parties and supersedes all previous agreements and understandings between the parties.

11. Governing Law: This Agreement shall be governed by and construed in accordance with the laws of North Carolina.
